**POSITION:**                   **HIGHWAY MAINTENANCE WORKER**  
The current vacancy is for one full-time position in the Lake County Highway Department at Two Harbors.

**MINIMUM QUALIFICATIONS:**  
High school diploma or G.E.D.; 1-year equipment operation or an equivalent combination of education and experience and a valid Class A Commercial Driver's license with a tank vehicle endorsement and without any of the following restrictions: air brakes, manual transmission, or tractor-trailer.

**RESPONSIBILITIES:**  
Responsible for operating equipment and performing skilled and semi-skilled manual labor to maintain and repair County highways, bridges, and other properties. Responsibilities may include operating and repairing on-road and off-road equipment and performing manual labor under all types of weather conditions.

**WORK TEST PERIOD:**  
Appointee to the position must successfully complete probationary period per contract.
